Now this deed witnesse	es as under:						

That the scholarship award is initially valid for a period of 01(One) year and would be extendable automatically periodically to a maximum of **04(Four) years** subject to the satisfactory performance

That the scholar shall serve in Pakistan for a period of **4(four)** consecutive years after completion of course of study, in any organization of Pakistan, serving Bond period will be equal to the number of years of education for which scholarship availed by the student. The 4 years serving period will include one (1) year internship period. ("Bond Period"), and report NEST regarding status of employment time to time and do not seek employment outside Pakistan without the prior approval of the Federal Government through NEST when the above written bond shall be void and of no

- iii) That the payment of allowances admissible under this scholarship program shall be made subject to the complete adherence to all rules and regulations governing the scholarship program as well as satisfactory performance in the authorized studies.
- iv) That in case of withdrawal/cancelation/close of scholarship due to any reason(s) under said scholarship, the awardee is not eligible for subsequent batches of said scholar scheme.
- v) That the scholar shall not avail any other scholarship without prior approval of NEST and in case of violation NEST may impose ban of 01(one) year w.e.f. date of cancelation/close of scholarship to avail any other scholarship.
- vi) That the scholar shall not proceed abroad during the studies and within the four years of serving Bond Period without prior approval/permission of NEST in any case.
- vii) That the scholar shall not change the specified course of studies/discipline and/or Institute during scholarship program at any stage nor register himself/herself for any other course or program/University/Institute either national or international, at any stage, failing to which shall cancel his/her scholarship immediately.
- viii) That the scholar may be eligible to join or change his/her employment organization within Pakistan only after procuring the prior approval of NEST during or after his/her course of studies.
- ix) That the scholar shall maintain the required standard and qualify the course/degree for which he/she was awarded scholarship.
- x) That the scholar shall fully obey the national laws of the country and shall strictly follow the rules & regulations of the university / institution where the scholar is enrolled for studies under said scholarship program.
- xi) That the scholar shall not incur any debts during scholarship period and will clear all outstanding bill(s) before completing his/her degree.
- xii) That the scholar shall regularly submit the six-monthly progress reports on his/her assigned Program through his/her supervisor/focal person to the NEST and a final comprehensive report immediately on completion of the study/training/research degree.
- xiii) That the scholar authorizes the NEST to approach the concerned University/Institute/Supervisor/Agency etc. to acquire any type of information as required.
- xiv) That the scholar shall be bound to submit his/her original educational documents/credentials, to institute till completion of his/her degree/scholarship program. However, NOC will be issued by the PNC to the scholar after completion of 4 years serving Bond Period.

- xv) That the scholar shall be bound to provide copies of credentials, or any other documents on the demand of NEST at any time during or after the course of study and service/employment period at Pakistan.
- xvi) That the scholar shall be liable to action under the law in force in Pakistan in case of failure to obey or act according to instruction(s) / order(s) of NEST about to work in Pakistan.
- xvii) That the scholar shall provide joining letter (with date of joining) issued by respective organization and the period of 4(four) consecutive years shall be started from date of joining in respective organization. The bond period of service/employment shall be count after completion of degree/date of close of case with approval of NEST.
- xviii) That if the Scholar breach or violate the terms of this Bond within the term of Bond Period then he/she shall be liable to pay/refund the Scholarship Amount to NEST as follows:
  - a) Breach the Bond in first year then Scholar will liable to pay 100% of Total Scholarship Amount.
  - b) Breach the Bond in second year then Scholar will liable to pay 75% of Total Scholarship Amount
  - c) Breach the Bond in third year then Scholar will liable to pay 50% of Total Scholarship Amount
  - d) Breach the Bond in fourth year then Scholar will liable to pay 25% of Total Scholarship Amount
- xix) That the scholar shall be liable to cancelation/disqualification of scholarship or debarred from study/training/research of any scholarship scheme of NEST or refund of expenditure amount with/without penalty or any other disciplinary action as NEST may consider appropriate if:
  - a) Fail to comply with the instruction(s)/order(s) of NEST.
  - b) Dual Scholarship without approval of NEST.
  - c) Any financial loss occurred to NEST due to scholar act(s).
  - d) Miss-statement or concealment of facts therein before by the scholar.
  - e) Engaged in any political, commercial or any other activity incompatible with program of studies.
  - f) Commit misbehavior the NEST/University/Institute/Supervisor; and
  - g) Fail to provide updated status of study/service and remain silent more than one (01) year.

- xx) That all the terms and conditions mentioned in the Award Letter issued to the institute shall be deemed as part of this deed of Agreement.
- xxi) That in case of breach of any of the above terms & conditions as well as those rules, terms and conditions of governing scholarship award, the scholar & guarantor shall be bound to pay the NEST a penalty @ 25% of Total Scholarship Amount paid as prescribed/assessed by the NEST besides compensate the NEST by making a refund of the total amount of expenditure incurred on scholar in Pakistani rupees.
- xxii) That the scholar & guarantor both are held firmly bound to NEST for all moneys, charges, costs, expenses and penalty determined/assessed by the NEST as having been incurred on or in respect of course of studies under the said Scholarship Program, which amount will not question to be paid to the NEST, we hereby bind ourselves, each of us, our and each of our heirs, executors, administrators jointly and severally.
- xxiii) That the amount of penalty and the compensation as prescribed and assessed by the NEST shall be final and conclusive and will not be challenged in any court of law or forum.
- xxiv) That all instruction(s), order(s), letter(s), email(s), notice(s) and other communication(s) etc. under this undertaking/scholarship award shall be deemed given hereunder when sent by NEST to Scholar & guarantor at the addresses given above.
- xxv) That the Scholar & surety/guarantor expressly submits and consents to the jurisdiction of courts in Pakistan, with respect to any claim or demand upon NEST upon this deed of agreement or any amendment or supplement hereto.

**AND THE SCHOLAR & SURETY/GUARANTOR FURTHER COVENANTS**, that in case of breach of any of the above terms and conditions as well as the rules / terms and conditions those governing nursing scholarship program and or failure by Scholar as directed by the NEST for the specified period, the Scholar & surety/guarantor shall be bound to pay the NEST a penalty @ 25% as prescribed by the NEST besides compensate the NEST by making a refund of the total amount of released by NEST in respect of him / her.
